#### Market area cooperation between bayernets, Eni Gas Transport Deutschland, E.ON Gastransport, GRTgaz Deutschland und GVS Netz intended

Aiming to create a joint Germany wide H-Gas market area, the above mentioned network operators check a market area cooperation under the umbrella of NetConnect Germany based in Ratingen. For this purpose, the founders have signed a memorandum of understanding with three network operators: Eni Gas Transport Deutschland S.p.A., GVS Netz GmbH and GRTgaz Deutschland GmbH.

This cooperation is to create an enlarged market area with a gas transmission system that will comprise some 14,800 kilometres of pipeline and handle the largest part of all H-gas transported in Germany. This market area involves more than 400 gas supply networks and offers an intensification of competition and increased liquidity at NCG virtual trading point

NetConnect Germany's business areas include balancing group management and the provision and operation of NCG virtual trading point and an information platform.

"NetConnect Germany stands for optimised processes, efficient data management and transparent information. With this envisaged extension we are sending a clear signal for forward-looking developments on the gas market and for easier network access," the cooperation partners said. The enlargement of the company is subject to approval by the Federal Cartel Office.

The aim of the enlarged group of shareholders of NetConnect Germany is to gain further partners or shareholders.
