



## Note regarding yearly price:

The network fees for firm freely-allocable capacities with a term of one gas year (reference price) are 6.71 €/(kWh/h)/a or 0.01838356 €/(kWh/h)/d in the market area Trading Hub Europe (THE), valid from 1 January 2025.

## Guidelines for the conversion of yearly prices into prices for periods of less than a year:

According to the decisions "MARGIT 2025" (BK9-23/612) no. 2) and "BEATE 2.0" (BK9-18/608) no. 2a) a multiplier applies to the shipping fee. The multiplier of a within-day product is 2.0, the multiplier of a daily product is 1.4, the multiplier of a monthly product is 1.25 and the multiplier of a quarterly product is 1.1. All shipping fees in this price list are <u>without</u> multipliers. For this reason, for all booking periods of less than a year the shipping fee has to be multiplied with the relevant multiplier.

The multiplier does <u>not</u> apply to the metering fee, the biogas levy and the quality conversion charge.

## Biogas levy and quality conversion charge 2025

Biogas levy: 1.0542 €/(kWh/h)/a or 0.00288822 €/(kWh/h)/d

Quality conversion charge: 0.6713 €/(kWh/h)/a or 0.00183918 €/(kWh/h)/d

## Tariff for DZK (Benchmarking)

As long as the preconditions stated in the decision "REGENT 2021" (BK9-19/610) dated 11 September 2020 regarding benchmarking tariffs are fulfilled for the duration of the booking the benchmarking tariff will be applied. This particularly refers to the rules of allocation, the hourly balance of the allocated points (Überackern 2, USP Haidach and 700069-8303-2) as well as the exclusion of the firm or interruptible use of the access to the virtual trading point. The exclusion of the access to the virtual trading point can be ensured by the selection of an appropriate balancing group. Otherwise, the general rules for tariffs apply to DZK.

Currently, there are ongoing discussions regarding a direct physical connection of the storage USP Haidach to Austria (market area east). In case of a direct connection of the storage Haidach to Austria the benchmarking tariffs at the storage Haidach cease to be effective and cannot be offered any longer.
